THE US, THE EU AND RUSSIA – THE NEW REALITY

September 12, 2015 Baltic Beach Hotel, Jurmala, Latvia

Since the last international conference of "The Baltic Forum" in May 2014, the situation in the world has continued to change rapidly in an unfavourable direction. The contradictions accumulated between the West and Russia have resulted in a full-fledged crisis, which together with the continuing Ukrainian conflict badly complicates challenges to ensure security both on regional and global level.

The escalation of tension overlaps with:

- Confident growth of China's economic and military potential and intensification of competition between the United States and the People's Republic of China;
- Progressing Middle East destabilization, growth of contradictions and radicalisation of the Islamic world;
- Economic and political stagnation of Europe;

Gradual decrease of the role of the former global leaders and a range of key supranational institutions (G7, IMF, World Bank etc.).

In recent months, a quantitative accumulation of factors of instability has taken it to a qualitatively new level - with extremely unpleasant prospects even for such a recently relatively calm region as Europe. This is indicated both by the heating of the crisis over Ukraine, and further escalation of conflicts in the Middle East with its growing negative impact on European territory itself.

This time, the challenges encountered in the system of regional and global security can no longer be stopped by the structures designed to ensure it without exercising very serious and timely effort. Foreign policy moves undertaken by the leadership of the most prominent international organizations and leaders of the major world powers are often either belated or turn out not to be sufficiently decisive, or, more dangerously, are initially based on erroneous assumptions and conclusions. The costs of such incompetence may turn out to be enormous if not unmanageable for all parties, including those of the Ukrainian crisis.
